## Terms and Conditions

The terms and conditions contained herein regulate and govern the Titans - Building Nations Awards and related promotional material (hereinafter referred to as 'Titans'), and pertain to all entrants and those who nominate them.

### Entering

1. The entrant must be an African citizen or a permanent resident.
2. The entrant must be over the age of 18 (eighteen) at the time of Titans, unless otherwise stipulated.
3. Lifetime achievers may only enter the Titans awards again if they are active in a different sector to the one in which they have achieved the lifetime recognition. They need to have been active in this sector for 3 years.
4. Continental Winners may only re-enter after 5 years of winning their award.
5. Previous finalists, country winners and regional winners may re-enter Titans
6. The entrant must provide CEO Global with all documents as per the checklist.
7. The deadline for entries is stated on the Titans promotional material. Late entries will not be accepted unless approved in writing.
8. CEO Global reserves the right to verify any information provided by the entrant.
9. CEO Global reserves the right to limit the number of entries made by an entrant.
10. Non-executive board members should not be nominated – the aim of Titans is to recognise men who exercise daily operational influence in their organisations.
11. The nomination process is confidential, and entrant will not be given the details of the individual who nominated them.

### Judging Process

12. The outcome of Titans is subject to the decision of the judges appointed for the various judging rounds, and their decision is final.
13. A Titans judge is not eligible to enter, nor to judge the entry of a company or department in which he or she may be involved in any capacity.
14. The right remains within the judging panel to change the sector in which the entrant entered.

### Winners and Finalists

15. Winners and finalists will be announced at various regional events across the continent.
16. CEO Global shall be entitled to publish information and photographs of the winners and finalists, and the Titans results, on its website, in its publications and in promotional material, without liability on the part of CEO Global (including remuneration for the use of such material).



17. Should CEO Global decide to issue awards, prizes and/or framed certificates, and should these not be claimed within 30 (thirty) days of the prize-winner being announced, the prize-winner forfeits the prize and CEO Global reserves the right to re-award or dispose of the award or prize.
18. Prizes may not be exchanged for cash or any other prize, nor are they transferable.
19. CEO Global reserves the right to re-award any prize to another finalist in any category should the winner be disqualified for non-compliance with these terms and conditions at any time.
20. Finalists and winners will make themselves available for future road shows and/or interviews during their reign as winner or finalist.
21. Finalists and winners agree to be interviewed by the media.
